Profile

After a PhD concerning non-governmental development organisations, I have become an expert in development in areas affected by disaster, conflict or fragility, with a special focus on aid-society relations: the impact of humanitarian aid on society and the ways in which people and institutions shape the organisation of aid relations. In this work, I have mostly used ethnographic methodologies (*aidnography*). My theoretical framework on humanitarian arenas analyses aid-society relations from a sociological, empirical perspective. It brings out how assistance for survival under duress is shaped by different actors in everyday practice and focuses on discourse, organization and power.

An important theme in my research concerns questions of humanitarian governance. Humanitarian governance refers to how multiple and diverse actors – with different normative frameworks and authority structures - interact in addressing humanitarian needs and crises. A major activity concerns my ERC advanced grant programme focusing on Colombia, DRC, Ethiopia, and global situations of climate-related displacement. Before this, I have led a research programme on disaster governance in cases where disaster collides with conflict. I am currently establishing a humanitarian studies centre, at the ISS of Erasmus University.

I have supervised 36 PhD candidates, 9 of these are ongoing and 27 have been completed. In addition to my academic research, I have always maintained a portfolio for applied assignments and advisory work, which has enhanced an intimate knowledge base of international organisational processes. My academic research is interactive, seeking dialogue with policy and practice on relevance, access and uptake of research, and I seek to incorporate my applied work in academic publications.

My research programmes since the completion of my PhD have taken place in a large number of settings affected by disaster, conflict and fragility, including in Afghanistan, Angola, Bangladesh, Burundi, Colombia, the Democratic Republic of Congo, Ethiopia, Eritrea, Guatemala, Haïti, Kenia, Mozambique, Nepal, North Iraq, Palestinian territories, Philippines, Rwanda, South Africa, South Sudan, Sri Lanka, Uganda and Zimbabwe.

My research programmes stand for qualitative inquiries into the everyday politics and practices of governance, institutions, actors and aid in crisis-affected areas, especially in Africa and Asia. They are mainly implemented by PhD candidates, and I have also managed around 30 academic staff, post-docs and contract researchers.

Since 2000 I have acquired 18 grants and large research contracts with a total value of 11 million Euro. I am a laureate of an ERC advanced grant, and previously VICI, VIDI and MAG-W personal grants of NWO. About 65% of my research has been academically financed, the remainder has been financed by the Dutch Ministry of Foreign Affairs, the British DFID and Dutch development organisations.

Policy advice, consultancies, and representation (see annex 2)

I have maintained a flow of advisory functions and contract research. Current engagements concern the development of a research centre for gender and development in Bukavu, Democratic Republic of Congo, and the organisation of the International Humanitarian Studies Association.

I have had many public engagements, ranging from parliamentary hearings to speeches at local Rotary clubs. I have ample media experience - TV interviews, radio appearances and numerous interviews in newspapers and contributions to op-eds and blogs. I aim to present an honest and realistic image of the wicked problems of fragility, the everyday practices of aid, and the messy realities of international relations.

Education

I have been responsible for a track in the Master of Rural Development Sociology on disasters, conflict and humanitarian aid. I have developed and taught three Master level courses on natural hazards and disasters; humanitarian aid and reconstruction and food crises. My teaching has always been evaluated highly positive by the students. At ISS, I have developed and teached a course in humanitarian studies.

In my post-graduate supervisions, I aim to ensure a good balance between analytical development and the need for training on methodology and academic skills. Strategies to achieve research uptake are also part of the research preparation of the PhD candidates.
