SUMMARY OF EXPERIENCE

Dr. Andrea Bartoli is an international affairs expert and a leader of academic institutions who has worked in the higher education sector as professor and senior administrator. He joined the <u>Community of Sant'Egidio</u> in 1970 and launched the <u>Sant'Egidio Foundation for Peace and Dialogue</u> in 2019. He was one of the founding members of the <u>Global Action Against Mass Atrocity Crimes (GAAMAC)</u> where he serves in its Steering Group. He is the Executive Adviser of the <u>Soka Institute for Global Solutions (SIGS)</u> and a member of the Board of Trustees the <u>Soka University of America</u>. He is a Fellow at <u>Columbia University – Advanced Consortium on Cooperation, Conflict & Complexity (AC4)</u>.

Dr. Bartoli was the Dean of the School of Diplomacy and International Relations (2013-2019) and of the School for Conflict Analysis and Resolution (2009-2013); the Drucie French Cumbie Chair of Conflict Analysis and Resolution at the School for Conflict Analysis and Resolution (S-CAR) at George Mason University (2007-2013). Dr. Bartoli is still a Senior Fellow at the Center for Peacemaking Practice at the renamed Carter School.

Before joining the S-CAR faculty, Dr. Bartoli worked at Columbia University through the Italian Academy for Advanced Studies of which he became the Deputy Director. While at Columbia he founded and directed the Center for International Conflict Resolution (CICR) at the School of International and Public Affairs (SIPA) where he connected to the Saltzman Institute on War and Peace Studies (SIWPS). While at CICR, he held the chair of the Columbia University Seminar on Conflict Resolution. He also conceived and launched the Master in Negotiation and Conflict Resolution.

Dr. Bartoli has served in numerous peacemaking processes, including Mozambique (1990-1992), Guatemala (1995), Algeria (1995), Kosovo (1998), Burundi (1999-2000), Democratic Republic of the Congo (1996-current), Casamance - Senegal (1994-current), the Central African Republic (2003-current) and South Sudan (2018-current). Dr. Bartoli was twice a participant in the U.S. State Department's testimony before Congress on Religious Persecution Abroad. He was part of the U.S. Department of State Working Group on Religion and Foreign Policy. He is now the Director of the Informal Exploratory Working Group - IEWG to gather open-source information about the Megaton to Megawatts - M2M program on nuclear disarmament.

Dr. Bartoli oversaw the development and implementation of CICR and S-CAR's successful interventions in Burma/Myanmar, East Timor, Colombia, Iraq, and the African Great Lakes Region. He has worked in the field with each of these programs. As well he has responded to partners' requests from countries such as Ivory Coast, Morocco, South Africa, Australia, Kenya, Ethiopia, Lebanon, Italy, Syria, Burundi, Uganda, DRC, and Tanzania. He has worked for and collaborated with both public- and private-sectors partners, such as the United Nations, the World Bank, the Global Coalition to Prevent Armed Conflicts, the Ford Foundation, the Hewlett Foundation, the European Union, Parliamentarians for Global Action, and the governments of Norway, East Timor, Portugal, Sweden, Poland, and

Switzerland. He also raised several million dollars to support CICR, S-CAR, and SFPD's research and program activities.

Prior to his coming to the USA, Dr. Bartoli served as the President of the Unità Sanitaria Locale (USL) 7 in Rome; founded and ran the Centro di Studi e Programmi Sociali e Sanitari (CSPSS); and taught at the Università di Tor Vergata Roma Tre.
