Marco Fasciglione (PhD) is **Senior researcher of International Law at Italian National Research Council** where he is PI of the research project on *Corporate human Rights and environmental due diligence and the promotion of the Corporate Responsibility (CO.RE.)*. **He has been awarded the national scientific qualification as Associate Professor in the area 12/E1 (international law)**. His scientific experience focuses in general on the international system of protection of human rights; specific main areas of expertise include the impact of business activities on human rights; business ethics and the protection of non-economic values of supply chains. Other research areas include the protection of the environment, the rights of vulnerable categories (migrants, disabled persons, elderly persons, etc.), and the impact on human rights stemming from the development of Artificial Intelligence technologies. Marco Fasciglione performs his research activities within national and international research projects. He has developed solid scientific relationships with Academies and other public and private institutions. **Former legal officer at the European Court of Human Rights**, he is member of the **Management Board of the EU Fundamental Rights Agency – FRA** and serves as Judge of the **Mission Appeals Tribunal (MAT) of NATO**. Marco Fasciglione has an extensive experience of evaluation tools and techniques of public and private policies in respect to human rights. **He has served as expert for national and international research institutions (REA-H2020, COST, EC DG Justice, MIUR-VQR)**.
