Lydia Velliscig is an associate professor at the University School for Advanced Studies - IUSS Pavia, where she is also a member of the Legal Sciences Research Group.

She is a member of the Academic Senate at the IUSS School, where she is also the Coordinator of the Placement Project. She is a member of the Board of Professors for the PhD in “Comparative Law, Private Law, Procedural Law, and Business Law” at the University of Milan.

Her academic experience includes teaching undergraduate and master’s degree courses, as well as courses within PhD programs.

Her research focuses on comparative and European private law, including topics related to insurance law, financial markets, and banking law. She is currently interested in the legal aspects of insurance and other financial risk protection tools. She has participated in several research projects that have received funding.

She is a member of the Società Italiana per la Ricerca nel Diritto Comparato (SIRD) and of AIDA (International Association for Insurance Law) – Lombardy section, where she is also a member of the Scientific Committee.

Lydia is also on the Editorial Board of the Italian journal *Diritto del mercato assicurativo e finanziario* (ESI) and serves as an Associate Editor of the international journal *Global Jurist* (De Gruyter).

Her main areas of publication are in comparative law, insurance law, and other risk financing tools. Recent publications include a monograph: *Assicurazione e “autoassicurazione” nella gestione dei rischi sanitari. Studio di diritto comparato*, Milano, Giuffrè, 2018, and several contributions, such as:
