## Open Call for Expression of Interest – Tenured Position of recognized researcher (R2)

Criminal law is experiencing significant transformations in the framework of the so-called regulatory revolution. Innovative models and strategies of governance of different societal contexts (privacy regulation; Corporate Compliance; Product Liability; Consumer Safety; Food Safety; Worksafety, Business integrity, Environmental protection) are overcoming the traditional command and control approach (CCA). They are based on the main idea of the involvement of individual and organized players in the regulatory process (i.e. metaregulation, reflexive regulation or responsive regulation). Criminal law is therefore called to play a pivotal role in this new forms of governance of risk dynamics connected to public governance and business activities. The design of innovative paradigms of legitimation, analysis and application of criminal law is needed in order to deal with crucial problems (i.e. corruption, organized crimes, environmental crimes, economic crimes) in line with the so called Criminal Law Governmentality (CLG).

In the attempt to strengthen its research, teaching and Third Mission capacity at a national and international level the [DIRPOLIS Institute](https://www.dirpolis.it) is planning **to open a tenure track position (RTT Researcher becoming Associate Professor after 3 or 6 years upon confirmation)** to support the development of the response capacity to the aforementioned needs.

**Profile.** We are looking for a legal expert in issues related to one or more of the following fields of interest:

- **Corporate Compliance and Enforcement in the domestic and crossborder dimension;**
- **Public and private corruption;**
- **Economic crimes and criminal risk management,**
- **The legal framework of the prevention and fight of organized crime;**
- **The transformation of criminal responsibility in the new metaregulatory scenarios,**
- **Criminal profiles of climate change and sustainability;**
- **Global criminal governance, Criminal Law Jurisdiction Pluralism and Legal Space Theory.**

The applicant should have a proven track of interest and expertise in one or more of the above mentioned fields. Strong written and verbal communication skills are required at least in English. Preference will be given to candidates with recent and relevant hands-on experience with applied research and academic experience including for instance the ability to apply successfully for competitive research funds at national and international level. **Activities to be performed.** The successful applicant will be required to teach, advise and mentor undergraduate and graduate students, develop an independent, externally funded research program, contribute to the ongoing research programmes and training activities, actively participate in all aspects of the Institute and of the Scuola Sant'Anna activities.

**Terms and Conditions.** The starting gross salary for a tenure track Assistant Professor in public Italian universities is € 44.207. The severance pay is equal to one month of gross salary for each year

of employment. As employer, the Sant'Anna School pays contributions to both the Italian social security and the Italian public health systems. Individuals who have conducted at least two years of research abroad may also qualify for a temporary reduced taxation regime (pursuant art. 44 of Italian Law 78/2010, taxation may be restricted to 10% of their Italian income for a period ranging from 5 to 12 years, depending on their family status).
