MINUTE OF THE PRELIMINARY MEETING

The Evaluation Committee for the selection of one tenure-track – probationary, assistant professor (ricercatore a tempo determinato) for the Academic Recruitment Field "Comparative Private Law" (SC 12/E2) – Academic Discipline "Comparative Private Law" (SSD IUS/02) at the Academic Faculty of Social Sciences – Institute of Law, Politics And Development (DIRPOLIS) of the Sant'Anna School of Advanced Studies - Pisa pursuant to Italian Law No. 240/2010, Art. 24 paragraph 3 letter B, as formulated before the entry into force of the Law 79/2022, appointed by Rector's decrees No. 345 of May, 23, 2023 and No. 404 of June, 12, 2023, consists of:

- Prof. Vittoria Barsotti, Full Professor of the Academic Recruitment 12/E2 "Comparative Law" at the University of Florence, designated member by the DIRPOLIS Institute;
- Prof. Michael Faure, Full Professor at the University of Maastricht;
- Prof. Andrea Fusaro, Full Professor of the Academic Recruitment 12/E2 12/E2 "Comparative Law" at the University of Genova.

The Committee convened for the first time, via teleconference, on June 13, 2023, at 12, from the following locations:

Prof. Barsotti located in Florence, connected via GMeet - vittoria.barotti@unifi.it.

Prof. Faure located in Maastricht, connected via GMeet – michael.faure@maastrichtuniversity.nl

Prof. Fusaro located in Genova, connected via Gmeet - andrea.fusaro@unige.it

The draft of the following minute was agreed on and approved by the members of the Committee.

Prof. Vittoria Barsotti was nominated as Chairperson and Prof. Andrea Fusaro was nominated as Secretary.

Pursuant to Art. 5 paragraph 2 of Legislative Decree No. 1172/1948, each member declared to have no kinship or affinity up to the fourth grade with any of the other members and that there are not reasons for abstention in relation to art. 51 of c.p.c.

The Committee reviewed the call (published on the School website <u>https://www.santannapisa.it/it/selezioni/selezione-pubblica-la-stipula-di-tre-contratti-di-</u>

<u>ricercatorericercatrice-tempo</u> as well as the Regulations of the School regarding the recruitment for tenure-track – probationary, assistant professors (Art. 24 paragraph 3 letter B).

The Committee then adopted a motion that the Committee's work should terminate by October, 28, 2023.

The Committee ascertained that Human Resources Office has communicated that five applications have been received, that two candidates have not been admitted to the selection. There are three candidates left, two of them have been admitted to the public interview and one has been admitted

with reserve because she has obtained the PHD abroad and asked to be admitted on the basis of research experience done abroad and the Committee have to decide if she can be admitted, according to article 2 of the call.

The selection will be carried out by means of a public interview about the qualifications, the publications and the research projects submitted by the applicants. During the public interview, the Committee will also assess the level of knowledge of the English language.

After the public interview, the Committee will attribute a score to the qualifications, to every publication submitted and to the overall scientific production of the candidates, including the research project, according to the parameters established by Ministerial Decree 243/2011 and to the criteria assessed in the present meeting.

The winner will be declared on the basis of the scores obtained.

Then the Committee assessed the criteria for the score attribution to the qualifications, to every publication submitted and to the overall scientific production of the candidates, according to the parameters established by Ministerial Decree 243/2011 and taking into account the minimum score for the proper assessment.

Criteria for the score attribution on the basis of the interview

The Committee will assign a maximum score of 100, allocated as follows:

QUALIFICATIONS - maximum score of 30, allocated as follows:

- a) PhD or equivalent, awarded in Italy or abroad: up to 5
- b) (where applicable) teaching activities at university level in Italy or abroad: up to 2
- c) documented training or research activities carried out in qualified institutes in Italy or abroad: up to 4
- d) project activities as regards the academic recruitment fields where applicable: up to 5
- e) organization, management and coordination or participation in national and international research groups: up to 4
- f) participation as a speaker in national and international conferences: up to 2
- g) national and international awards for research activities: up to 4
- h) European degree recognised by international Boards as regards the academic recruitment fields where applicable: up to 2

The Committee will assign a score to each abovementioned item in relation to its significance in terms of quantity and quality of the research activities carried out by the candidate.

PUBLICATIONS - maximum score of 50

Publications will be assessed along with texts accepted for publication in accordance with regulations as well as the essays included in collective works and articles published in journals in paper or digital format, with the exception of internal notes or departmental reports; the PhD or equivalent thesis will be assessed too, even though unpublished.

The evaluation of scientific publications will be carried out on the basis of the following additional criteria:

a) originality, innovation, methodological rigor and relevance of each publication;

- b) coherence of each publication with the academic recruitment field or with closely related interdisciplinary subjects;
- c) scientific relevance of each journal / publisher and its impact factor within the scientific community;
- d) analytical determination, on the basis of guidelines recognized by the relevant international scientific community of the individual contribution of the researcher in the case of works carried out in partnership;

The Committee, balancing the scores, in the case of works carried out in partnership, shall pay particular attention to the individual contribution of the researcher, considered also in terms of originality, innovation, methodological rigor and relevance of each publication.

The Committee will assign the following scores to the publications:

- Monographs: up to 8
- Articles in journals of international reputation: up to 4
- Articles in journals of national reputation: up to 2
- Chapters in books: up to 2

OVERALL CONSISTENCY OF THE SCIENTIFIC PRODUCTION - maximum score of 20 to 100

The Committee shall also assess the overall consistency of the scientific production of the researcher, the intensity and the temporal continuity of such production, with the exception of periods of involuntary removal from the research with particular reference to parental functions – such periods should be adequately documented.

In order to be eligible for the position, the applicants shall score a number of points equal or greater than 70.

The Committee decided that the maximum duration of the public interview with the candidates shall not exceed 20 minutes; during the interview, the Committee will also evaluate the level of knowledge of the English language using a summary assessment (i.e. not sufficient – basic – good – very good – excellent).

For the assessment of the level of knowledge of the English language, the candidates will be asked to read and translate a passage from an English text related to the topics of the selection/part of the interview will be conducted in English.

The Committee ascertained that on May 31, 2023, had been published on the web site of the School the notice that the interview scheduled on June 19, 2023 has been postponed and that the date of the interview and the list of admitted candidates will be published on the web site within June, 30, 2023.

The Committee decided that the interview will be on July 10, 2023, at 9.30.

The Committee decided to reconvene on June 14, 2023, at 19 in order to know the list of the candidates.

At the end of the meeting, the Committee decided that the Chairperson would send a signed copy of this agreed minute to the Staff Office, together with the declarations of approval by the other members of the Committee. These declarations form an integral part of this agreed minute.
