- CONSIDERING THAT Scuola Internal Faculty/Academic Staff is unable to offer teaching in the specific areas required;
- CONSIDERING THAT the necessary additional funds are available;

HAS DECIDED AS FOLLOWS

In the framework of the Advanced Training Course: "Training Programme on Civilian Peacebuilding Capacity, Johannesburg, South Africa," according to the schedule prepared by the Course Director, professor Andrea de GUTTRY for June 2014, the Scuola announces the selection of the experts for the performance of the following lectures (which will be held in the period 23 to 27 June 2014 in Johannesburg, South Africa):

The gross amount provided for each of the two sets of lectures listed above is Euro 1,000 (price determined on the basis of the Inter-ministerial Decree no. 313/2011 laying down the parameters for the determination of the remuneration payable to the holders of the contracts referred to in Article 23, paragraph 2, of the Italian Law no.240/2010, and based on what is indicated in the Resolution of the Board of Directors no. 57 of 28.03.2013 and later. There will be no refund of any expense (such as travel accommodation, etc) incurred in for the delivery of the lectures. Applicants must have a University Degree, awarded after the completion of at least a three-year Bachelor degree, or at least five years relevant experience in the fields related to this announcement. They must have a good working knowledge of English. Applicants must meet these requirements at the time of the application.

All applications are to be submitted filling in the attachment "A" prior 31st March 2014 12.00 (CET). Late applications, whatever the reason for the delay, will not be taken into consideration.

Candidates must attach to the application:

- a) CV;
- b) scanned copy of their passport.

List of successful applicants will be released on the web-site of the Scuola. Record of the selection process, will be approved by official act of Deputy Rector for Higher Education Department.

The selection committee will decide according to the following criteria:

- a) level of education (Degree, PhD, Master, etc.)
- b) relevance of the professional experience of the candidates to the specific contents of the lectures for which they apply
- c) publications and their relevance to the content of the lectures for which they apply
- d) previous educational experiences on topics related to the area of teaching for which the candidate is applying

If selected applicants are already employed by Italian Public Administration, they must submit the permission to teach issued by their competent authorities.
