## The Directors



**Edoardo Bressanelli** is 'Montalcini' Assistant Professor in Political Science at the Sant'Anna School of Advanced Studies, Pisa. He holds a PhD in Political and Social Sciences from the European University Institute and, before returning to Italy, has been a Senior Lecturer in European Politics at King's College London, where he is affiliated as a Visiting Senior Research Fellow. His research focuses on EU institutions and decision-making, political parties, British and Italian politics. He has published in journals such as *Comparative Political Studies*, the *European Journal of Political Research*, the *Journal of European Public Policy*, among others. He has been a consultant for the European Parliament, most recently on 'Institutions and Foreign Interferences'.

**Giuseppe Martinico** is Full Professor of Comparative Public Law at the Sant'Anna School of Advanced Studies, Pisa. Prior to joining the Sant'Anna School of Advanced Studies he was García Pelayo Fellow at the Centro de Estudios Políticos y Constitucionales (CEPC), Madrid, and Max Weber Fellow at the European University Institute, Florence. His research interests cover both comparative and European law, fields in which he published extensively, including two monographs in English (one with Elgar and one with Routledge). He has published extensively in international peer-reviewed journals in three languages (English, Italian and Spanish).



**David Natali** is Full Professor at the Sant'Anna School of Advanced Studies, Pisa. He holds a PhD in political science from the European University Institute. The specific focus of his research is the comparative analysis of pensions, the EU coordination of social protection and social inclusion policy, the Lisbon Strategy and the Europe 2020 Strategy. He has been involved in several European integrated projects and networks of excellence financed through the 6th and 7th Framework Programmes (including NEUJOBS, NEWGOV, INTUNE, RECOWOE). He coordinated several research projects on pensions and the EU social dimension and the comparative analysis of pension reforms.



## The Faculty



**Gianfranco Baldini** is an Associate Professor of Political Science in the Department of Political and Social Sciences of the University of Bologna (Italy). He has held research and teaching positions at the Universities of Pennsylvania, Frankfurt, Sheffield and Lyon. His research focuses mainly on the comparative dynamics of populism, Euroscepticism (Brexit), party politics and representation.



**Francesca Biondi Dal Monte** is currently Assistant Professor in Constitutional Law at the Scuola Superiore Sant'Anna, where she is the coordinator of the Dream research area (Data, REsearch and Analysis on Migration). She has collaborated with several public administrations, including the Ministry of Labour and Social Policies, on issues related to the protection of social rights, the immigration and the right to asylum in Italy. At the Scuola Sant'Anna she coordinates the Jean Monnet Module Mars ("Migration, Asylum and Rights of Minors").



**Nicola Chelotti** is Lecturer in Diplomacy and International Governance at the Loughborough University London. His teaching and research interests focus on negotiations, diplomacy and regional/international organizations, the EU in particular. The underlying theme is to understand how informal practices emerge in international interactions and shape policy processes and outcomes. After completing his first degree in Political Science at University of Pisa (joint degree with Sant'Anna School of Advanced Studies), Dr Chelotti attained an MA in International Affairs (Diplomacy/International Cooperation), at ISPI (Milan) and an MSc in EU politics at the London School of Economics and Political Science. He then went back for Italy for my PhD (University of Florence), which investigated the decision-making processes of EU foreign and defence policy. Before joining Loughborough University (in 2016) as Lecturer in Diplomacy and International Governance, Dr Chelotti was an LSE Fellow in the Department of International Relations, at the London School of Economics.



**Edoardo Chiti** is Full Professor of Administrative Law at the University of La Tuscia, Viterbo and at the Sant'Anna School of Advanced Studies, Pisa. He is member of the European Group of Public Law and of the Istituto per le ricerche sulle pubbliche amministrazioni – Irpa. He is member of the Scientific Board of the *Giornale di diritto amministrativo*, member of the Advisory Board of the *Revista de Derecho de la Unión Europea*, and member of Advisory Board for the legal publications of the Italian publisher Il Mulino. His main research interests are EU administrative law, global and comparative administrative law, and the administrative law of the market.



**Thomas Christiansen** joined Luiss Università Guido Carli as a Professor in the Political Science Department in September 2019. He previously held positions at Maastricht University, at the European Institute of Public Administration, at Aberystwyth University of Wales and at Essex University. He is Executive Editor of the *Journal of European Integration* and co-editor (with Sophie Vanhoonacker) of the 'European Administration Governance' book series at Palgrave Macmillan. He has published widely on different aspects of European Union politics. He recently co-authored, with Emil Kirchner and Uwe Wissenbach, *The European Union and China* (London: Palgrave, 2019) and co-edited, with Diane Fromage, *Brexit and Democracy – The Role of Parliaments in the UK and the European Union* (London: Palgrave, 2019).



**Carlos Closa Montero** is part-time Professor at the School of Transnational Governance and Professor at the Spanish National Research Council (CSIC). Before joining the STG, Closa was Director of the European, Transnational and Global Governance research area at the Robert Schuman Centre's Global Governance Programme. He has also been Deputy Director at the Centre for Political and Constitutional Studies (CEPC) in Madrid, and member of the Venice Commission for Democracy through Law of the Council of Europe. He was formerly a Senior Lecturer in Political Science at the University of Zaragoza (Spain) and lecturer at the Universidad Complutense de Madrid.





**Emilio De Capitani** is the former secretary of the European Parliament civil liberties committee (LIBE) and executive director of the Fundamental Rights European Experts Group (FREE). He is also an Adjunct Professor at the Queen Mary University, London, the Sant'Anna School of Advanced Studies, Pisa and at the University of Naples "L'Orientale".



**Giacomo Delledonne** is a postdoctoral researcher in Comparative Constitutional Law at Sant'Anna School of Advances Studies in Pisa. From 2015 to 2016, he conducted postdoctoral research at the Institute for European Studies of Université Saint-Louis in Brussels. Previously, Delledonne worked as a trainee clerk at the Italian Constitutional Court under Justice Sabino Cassese (2010-2011).

He worked as university trainee at the International Court of Justice (The Hague), assisting H.E. Judge Cançado Trindade and H.E. Keith (2010/2011). Dr Fontanelli is a fellow of the Higher Education Academy, a member of the Centre for Judicial Cooperation of the European University Institute of Fiesole (Italy) and a member of the International Law Association. Dr Fontanelli is co-rapporteur of the ILA Committee on the Procedure of International Courts and Tribunals.



**Justin O. Frosini** is Associate Professor of Comparative Public Law at Bocconi University. He has published copiously in English and Italian in the field of comparative constitutional law with particular attention for federalism, regionalism and devolution, Brexit and the European Union, constitutional justice and forms of government.

He is also an economics columnist for La Repubblica and was a member of the editorial board of the Financial Times. **Dimitry Kochenov** is Professor at the University of Groningen, where he holds the Chair in European Constitutional Law and Citizenship. Prof. Kochenov's research focuses on Comparative and EU Citizenship Law; Principles and Enforcement of EU Law with an emphasis on the Rule of Law; EU External Relations Law, and the Law of the EU's Overseas.





**Brigid Laffan** is Director and Professor at the Robert Schuman Centre for Advanced Studies and Director of the Global Governance Programme at the European University Institute (EUI), Florence. She was Director of the European Governance and Politics Programme until August 2020. In August 2013, Professor Laffan joined us after leaving the School of Politics and International Relations (SPIRe) University College Dublin (UCD), where she was Professor of European Politics. She was Vice-President of UCD and Principal of the College of Human Sciences from 2004 to 2011. In November 2018 she was ranked among the women who shape Europe by POLITICO and was also awarded by the University of Limerick Alumni Association with its highest honour. In September 2014 Professor Laffan was awarded the UACES Lifetime Achievement Award. In 2012 she was awarded the THESEUS Award for outstanding research on European Integration. In 2010 she was awarded the *Ordre national du Mérite* by the President of the French Republic.



**Yves Mény** is Professor of political science at the LUISS School of government. He was also President of the European University Institute in Florence, Italy and of the Sant'Anna School of Advanced Studies, Pisa. He is a graduate in Law and obtained his PhD in Political Science in 1973. His career has taken him worldwide and he has been a Visiting Professor at many universities including New York, Seattle, Mexico, Paris, Madrid, Rome and Bologna. In 1993 he was appointed Director of the newly-founded interdisciplinary Robert Schuman Centre for Advanced Studies at the European University Institute in Florence. Professor Mény has been a member of numerous editorial committees, including Journal of Common Market Studies, South European Society and Politics and of the Journal of Public Policy, Stato e Mercato, and Administration and Society. He sits on many research committees, including the Review Panel for the Swiss National Science Foundation. He is a member of the Bureau of Political Advisers, set up by the President of the European Commission. He was Chairman of Expert Group on Foundations and Research and Development, European Commission and in 2000–2003 he was Chairman of the Executive Committee of the European Consortium for Political Research (ECPR). In 1999–2001 he was a member of the Conseil National d'Evaluation des Politiques Publiques and has served on the Piano Strutturale Board of Florence, a guiding committee for the structure and development of the city. His main areas of expertise are comparative politics, public policy, European Union affairs, and political and administrative institutions.





**Christine Reh** is Dean of Graduate Programmes and Professor of European Politics at the Hertie School. Her work focuses on the European Union's institutions, politics and legitimacy, with a particular interest in decision-making processes, informal governance and politicisation. Her current research explores the impact of national (electoral) politics on supranational actors and law-making. She previously held academic positions at the College of Europe in Bruges (Belgium) and at University College London, where she maintains an affiliation with the Department of Political Science. She is also an editorial board member of the *Journal of European Public Policy*.



**Marcello Ranucci** is a policy officer at the European Commission, DG EMPL, in the unit coordinating the European Semester (the EU framework for the coordination of macroeconomic and social policies).
