MINUTES OF THE THIRD MEETING

The Evaluation Committee for the selection of one tenure-track – probationary, assistant professor (ricercatore a tempo determinato) pursuant to Italian Law No. 240/2010, Art. 24 paragraph 3 letter B for the Academic Recruitment Field "Hydraulics, Hydrology, Hydraulic and Marine Constructions" (SC 08/A1) – Academic Discipline "Hydraulic Structures, Maritime Engineering and Hydrology" (ICAR/02), at the Institute of Life Sciences of Sant’Anna School of Advanced Studies - Pisa, appointed by decree No. 210 dated April, 19, 2021, by the Rector, consists of:

- Prof. Aurelia Sole, Full Professor of the Academic Recruitment Field "Hydraulics, Hydrology, Hydraulic and Marine Constructions" (SC 08/A1) – Academic Discipline "Hydraulic Structures, Maritime Engineering and Hydrology" (ICAR/02) at the University of Basilicata;

The Committee convened for the third time, via teleconference on the platform MEET at this link: meet.google.com/ioa-ogoi-pce, on August, 2, 2021, at 9 a.m. from the following locations:

The draft of the following minutes was agreed on and approved by all members of the Committee.

The President verified the presence of all members of the Committee and declared the session open. Each member of the Committee declared to have accessed online -- and examined in detail -- the documents submitted by the candidates. Upon a thorough discussion that involved all Committee members, a collegial examination of the documentation led to a summary of the qualifications, curriculum and scientific production of the candidates, upon comparison of the summaries that each member had prepared. This will form the basis for the detailed breakdown, agreed by all members, underpinning the final evaluation of qualifications, publications.

At 10 a.m. the Committee completed the comparative examination of the documents supplied by the candidates and opened the link, published on the School website, to let the candidates in and start their public interviews.

The Committee verified that only two candidates, Forzieri and Rossetto, had joined the meeting. The Committee has checked the waiting room of the call until the end of the session. Two applicants (Anghileri and Ranaee) did not join the meeting, nor contacted the offices to retrieve the link for the connection. Therefore they have been excluded from further evaluations.

The President informed the candidates that their interviews will be held in alphabetic order and invited them to send him via e-mail a copy of the ID document they had submitted with their application (Annex 1). The President also invited all candidates to attend the interviews of the other. The documents sent by the candidate constitute Annex 1 to these minutes. The Committee also noted that, in addition to the two candidates in attendance, no other interested parties were connected.

The President, after having verified the match of the document sent by e-mail with the one attached to the application and visually identified the candidate, started the interview with Dr. Giovanni Forzieri. The President preliminarily asked Dr. Forzieri to illustrate his research project. A Q&A session followed, to which all Committee members participated. The session was centered on the research project presented, and on various topics relevant to the call for applications. The interview lasted for 45'. During the interview the Committee also assessed the level of knowledge of the English language.

Then the President, after verifying the match between the document sent by e-mail with the one attached to the application and visually identified the candidate, started the interview with Dr. Rudy Rossetto. The President preliminarily asked Dr. Rossetto to illustrate his research project. A Q&A session followed, to which all Committee members participated. The session was centered on the research project presented, and on various topics relevant to the call for applications. During the interview the Committee also assessed the level of knowledge of the English language.

At the end of the interviews, the Committee ended the connection with the candidates.

After a brief recapping session, the Committee adjourned its works to August, 3 at 9 a.m. to complete the evaluation process of the candidates owing to urgent commitments of some of its members.

On August 3, 2021 at 9 a.m. the Committee joined the link meet.google.com/ioa-ogoi-pce,

The Committee, after a thorough discussion that involved all of its members, assigned collegially agreed scores to the qualifications, to each publication submitted by the candidates, and to the overall consistency of the scientific production, on the basis of the criteria defined in the preliminary meeting. The scores assigned are listed in Annex 2.

Thereafter the Committee summarised the scores assigned to the candidates as follows:

Rossetto	35	26.08	16.33	77.42

On the basis of scores obtained, the Committee declared Dr. Rossetto the winner of the selection process.

Therefore, the Committee declared properly completed its works. The Committee asked the President to send a signed copy of these minutes to the Staff Office, jointly with the declarations of approval by the other members. These declarations are integral part of these agreed minutes.

The meeting was adjourned at 11:00 a.m.
